#### **School Priorities**

KE shared a summary of last year's school priorities and how these have supported and informed the new priorities for 2022-23.

#### Oracy

- Little Wandle Scheme purchased
- New school library

KE summarised work that has been achieved on the on Cornerstones Curriculum and how this is now embedded into the daily planning.

## 7.50pm MG joined meeting

KE shared this year's school priorities with the committee and discussed the areas the development.

PRIORITIES FOR 2022-23	
Quality of Education	To enhance the quality of teaching and learning of Reading and Writing by focussing specifically on phonics, Whole Class Reading, Grammar, Punctuation

and Spelling, and handwriting so that pupils, especially those children with SEND, those at WTS and the lowest 20% make better than good progress. To embed and enhance the use of oracy in class to support pupils' learning and progress in all subjects, resulting in improved confidence, communication and collaboration skills alongside enhanced assimilation of knowledge and understanding for all. To increase the number of children working at Greater Depth across the curriculum through reinvigorating questioning skills and enriching the provision of challenging learning opportunities. Behaviour and To promote the school's Cornerstones Curriculum values **Attitudes** to support all children to become resilient and positive learners, whilst showing excellent behaviour on their journey to be responsible citizens at all levels of life. Personal To continue to actively promote all aspects of pupils' Development and staffs' welfare including mental wellbeing. Leadership and For subject leaders to continue to enhance and enrich Management their WCPS curriculum areas by improving teaching, learning and assessment, focussing particularly on the level of challenge and support and ensuring the WCPS Cornerstones are fully embedded. For the school to build on parental engagement so that parents understand how to and feel better able to support their child's learning and development.

Governors asked how Leadership and Management would achieve their areas. KE explained that they will:

- Manage teacher workload
- Allocate time to further develop subject areas
- Facilitate time with SENDco for support with paperwork

Governors asked that link governors for curriculum areas be advised of anything they can do to support with this.

KE informed governors that already the Online Safety learning necessary is being allocated within teacher's directed time. Governors discussed the implications of the Online Safety bill currently before parliament and how that this should and will be a priority for the whole school community. Governors deliberated how this can be achieved.

Governors asked if the Rights respecting School's information would be reflected in the behaviour Policy. KE said this is currently being reviewed for this purpose; information will also be included in the Home School Agreement.

Governors asked how the Cornerstone Curriculum had been developed. KE explained that teachers had worked together to develop the cornerstones and their values. Now as part of the monitoring schedule they analyse how they link with learning objectives. Parent governors reported good feedback from their children.

#### 8. CHAIR UPDATE

# **School Uniform Policy** (new statutory policy)

TJ explained that KE had conducted a benchmarking activity amongst the cluster school group and that Wimbledon Chase have one of the more economically priced uniforms. PE t-shirts cost was a consideration to be looked into in the future.

From an ECO perspective school is looking at extra opportunities to sell preused uniform, The Friends have offered to support with this.

The school already provided free pre-used uniform where there is known hardship.

Governors agreed to ratify the policy unanimously.

Governors were asked to re-agree the Governors Code of Conduct for the new academic year 2022.23, this was agreed unanimously.

## 9. CHAIR OF COMMITTEE REPORTS

#### **Pay Committee**

TJ informed governors of an extraordinary meeting of the Pay Committee (June 2022).

KE called this meeting to discuss a small restructure of the Senior Leadership team. Since JA had left the school the previous 3 Assistant Headteachers had all been Acting Deputy Headteachers, during the recruitment for Headteacher and since. Although the team works well KE now feels the school needs someone who will take over as assessment lead, data analysis with minimum financial impact to the budget. This slight restructure will mean that one of the team becomes a full time deputy with two reverting back to Assistant Headteachers.

KE has consulted with Merton HR department and the school's MEP to seek the best way to do this.

The Pay Committee felt that due diligence had been completed. KE said that he will be advertising and inviting applicants for the position shortly and asked for a governor to support the interview process/panel.
