- encourage good attendance and address any concerns with parents or carers where necessary
- ensure e-safety requirements are met at all times and teach the children to be good digital citizens

Parents - To help my child at school, I will do my best to:

- support the school's policies and expectations as set out in the behaviour for learning policy
- ensure that the school is notified of any changes to emergency contact details
